(1) The temporary recognition accorded to the school is valid upto 16.12.2023 and is to be renewed at an interval of every three years.

The grant of recognition is available initially for classes Pre-KG to VIII Std and to be extended for Secondary / Senior Secondary Classes subsequently in due course of time.

The School shall abide by the provisions of the Right of Children to Free and Compulsory Education Act, 2009 and the Tamil Nadu Right of Children to Free and Compulsory Education Rules, 2011.

(8) The School shall ensure that,-

- no child admitted shall be held back in any class or expelled from School (i) till the completion of elementary education in a school;
- no child shall be subjected to physical punishment or mental harassment. (ii)
- no child is required to pass any board examination till the completion of (iii) elementary education;

every child completing elementary education shall be awarded a (iv) certificate as laid down under rule 21.

inclusion of students with disabilities / special needs as per provision of (v) the Act.
